# **RESULT NOTICE**

## **THEATRE ASSISTANT (O.T.)**

#### M.C.D.

An examination for selections to the post of Theatre Assistant (O.T.), (Post Code – 75/07) in the M.C.D. was conducted by the DSSSB on 21.09.2008. During the selection process, it was observed that a number of candidates who were higher in merit did not possess requisite experience rather they had qualification of Diploma in Operation Theatre Technology. Therefore, a clarification vide letter dated 27.04.2009 & reminder dated 03.06.2009 was sought from M.C.D. as to whether the candidates having 02 years Diploma in operation theatre technology needs experience or not. Since no reply has been received from the M.C.D. in this regard, the Board took a considered view to process the selections to the post as per available Recruitment Rules provided by the M.C.D. to the Board vide letter No. ADC(H)/2007/4938 Dated 24.05.2007.

Accordingly, on the basis of the One Tier Main Exam held on 21.09.2008 for the post of Theatre Assistant (O.T.), (Post Code – 75/07) in the M.C.D. following candidates have been provisionally selected in the pay scale of Rs. 3200-85-4900 (pre – revised).
