NOTICE SHORTLISTING CANDIDATES FOR APPEARING TIER-II EXAM FOR THE POST OF MOTOR VEHICLE INSPECTOR UNDER POST CODE 21/12 AND 42/13 IN TRANSPORT DEPARTMENT

DSSSB conducted a combined examination for recruitment to the post of Motor Vehicle Inspector (Transport Department) under post code 21/12 & 42/13 respectively. On the basis of performance of the candidates in written examination held on 28.12.2014 the following candidates have been Short-listed against 10 times of number of the advertised vacancies in each category, subject to availability of candidates getting the cut off marks fixed for short-listing in the category.

The list is Roll number wise and does not reflect the merit position of the candidates. The candidates shortlisted for appearing Tier-II exam is purely provisional subject to the verification of credentials, for determination of eligibility of the posts will be carried out by the Board after completion of Tier-II examination.

Reserved category candidates short-listing in UR category in written examination and obtained marks above or equal of last qualified UR candidate and have not availed any benefit of reservation, have been declared qualified for appearing in Skill test against UR vacancies and their final selection to the post shall be considered in UR category subject to availability of vacancies, otherwise in their respective category if eligible otherwise for selection in the said category.

The candidates have been short-listed for Tier-II exam ten times in nos. against the available vacancies with taking all the candidates having scored marks equal to cut-off marks for each category for short-listing even if, it results in increasing the candidate's ratio 1:10.

Mere inclusion of name in short-listed candidates does not confer any right of candidate over the post. The final selection will be carried out at the time of final selection after Tier-II examination on obtaining documents of candidates. At any stage of recruitment, if any wrong or misleading information is noticed by the Board in respect of any candidate his candidature will be liable to be rejected.

As at this stage, short listing of candidates have been done on the basis of information in master data and position in merit list, thus all reservation and concessions given to candidates in reserved categories are purely provisional and extent of such reservations or concession will only be verified at the time of final selection for these post.

Accordingly, candidates equal to 10 times no. of vacancy in each post code have been short-listed including Horizontal reservation like Ex-serviceman etc and these candidates have been shortlisted in separate respective heads in each post code.

All bracketed candidates (having equal marks at cut-off) have been considered for the post and therefore in some cases number of candidates short-listed are more than 10 times the no. of vacancies.

Reservation of other state candidates/migrant SC/ST candidates will be based on the Govt. policy/clarification from the Government or by any other court of law. At this stage all SC/ST candidates irrespective of their nativity or residence have been considered for short-listing in these post codes. Further aspect related to reservation and extent of concession to all reserve categories will be scrutinized and decided at the time of final selection.

Short listing of candidates who were allowed to appear in written examination is purely provisional and their result will be processed after decision of court cases pending before the Ld. CAT.

Candidates whom roll number are indicated in the result notice will be called for Tier-II examination separately.

The result notice is issued with the approval of the Competent Authority, DSSSB.
