ASSISTANT (OT/CSSD) IN HEALTH & FAMILY WELFARE DEPARTMENT UNDER POST CODE 35/2014

- 1. The DSSSB vide result notice 507 dated 09.05.2017 has declared the results 13 candidates for the post of Assistant (OT/CSSD) in Health & Family Welfare Department under post code 35/14.
- 2. Candidature of candidate having Roll No 12006098 was kept pending in UR category for want of details of acquiring the Diploma, the candidate has now furnished the same.
- Candidature of candidates having Roll No 12002679 and 12005887 were pending in UR and SC category respectively for want of clarification from user department regarding admissibility of Diploma in Anesthesia for the post. The Health and Family Welfare Department vide their letter No. F.1(325)/TRC/H&FW/2009/11677 dated 08.08.2018, has clarified that Director-Professor & HOD, Department of Anesthesia & Intensive care, GB Pant Institute of PGMER vide letter dated 23.07.2018 has stated that candidate with Diploma in "Anesthetic Assistant" cannot be considered at par with a candidate possessing Diploma in "Operation Room Assistant". Accordingly the candidature of candidates having roll number 12002679 and 12005887 is hereby rejected.
- 4. On the basis of the merit list based on marks scored by the candidates in Academic qualification Assessment and Interview for the post was held on 11.03.2015, and after preliminary scrutiny of eligibility for the post as per the provisions of the statutory Recruitment Rules and terms and conditions of the advertisement, the following candidate is provisionally selected to the Assistant (OT/CSSD) in Health & Family Welfare Department under post code 35/14:

- 6. The candidature of candidate having Roll No 12005585 is still pending in SC category for want of clarification from user department regarding admissibility of age relaxation to contractual employees working in medical institution of MCD.
- 7. The selection of the above 01 candidate shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 8. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application form vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.
- 9. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
