## RESULT NOTICE NO: 774 DATED 26.03.2021 DRIVER, LMV, POST CODE-155/14 IN COLLEGE OF ART

The DSSSB vide its advertisement No. 01/14 had advertised 01 vacancy (UR-01) for the post of Driver, Post Code-155/14 in College of Art. The date of opening of application for was 27.01.2014 with closing date of 27.02.2014. Tier-I written examination in offline mode was held on 17.11.2019 and driving skill test for the post code-155/14 was held on 17.02.2021.

- 2. All 193 candidates who had appeared in written examination were informed through notice No. F. No. 229/Result/Driver /Int. Cell/DSSSB/2019-20/790-98 dated 17/02/2020 on the Board's website i.e. <a href="www.dsssb.delhi.gov.in">www.dsssb.delhi.gov.in</a> that their marks for the examination dated 17/11/2019 for the post of Driver, LMV, Post Code-155/14 have been declared and the same were available in their account in OARS module and vide said notice dated 17/02/2020. Further, vide notification dated 22/01/2021; the shortlisted candidates were called for driving skill test held on 17.02.2021. Thereafter, the candidates who qualified the written examination as well as driving skill test were shortlisted for uploading of their documents in the e-dossier w.e.f. 08.03.2021 to 22.03.2021 with the specific direction that if any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 3. On the basis of marks secured in the written examination & qualifying the driving skill test and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement no. 01/14, 01 Candidate under UR category has been provisionally selected for the post of Driver, Light Motor Vehicle, Post Code-155/14 in College of Art, subject to his fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in his online application form and edossier:-

- 4. As per RRs the essential qualifications is (i) Matriculation or its equivalents from a recognized Board/University & (ii) Driving License of Light Motor Vehicle with two years of unblemished experience in the line. The User Department is requested to check the unblemished experience of the above candidate before issuance of any offer of appointment. The selection is provisional and subject to the satisfaction of user department regarding experience certificate furnished by above candidate. If he found not eligible, his e-dossier may be returned after cancellation of his candidature.
- 5. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to his photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting

applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 11. The result process for the above post code stands closed in all respect.
- 12. A waiting panel has been prepared which will be valid for a period of one year from the date of declaration of result i.e. upto 25.03.2022.
