Sub:- Release of Tier-I exam marks for the post of Manager (Traffic) (post code 05/22) in DTC and shortlisting for candidates for tier-II.

1. The DSSSB vide its advertisement no. 06/22 dated 11/04/2022 with closing date 09/05/2022 had advertised 13 vacancies (UR-05, EWS-01, OBC-04, SC-02, ST-01) for the Post of Manager (Traffic) under post code 05/22 in Delhi Transport Corporation (DTC).
2. The marks obtained by 4709 candidates who duly appeared in written examination held on 31/10/2022 have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dssbonline.nic.in
3. Based on the performance in Tier-I written examination (online mode), out of these 4709 candidates, total 467 candidates (UR-101, EWS-97, OBC-100, SC-100, ST-69) have been provisionally shortlisted to appear in Tier II examination subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms:

4. The shortlisted candidates shall be called for Tier-II examination separately.
5. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II examination does not entitle them any right over the post.
6. The minimum qualifying marks in written examinations as per the Board advertisement is 40% for UR/EWS Category, 35% for OBC Category and 30% for SC/ST Category candidates.
7. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
