## POST GRADUATE TEACHER (Math) (FEMALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 142/2012

The DSSSB vide result notice No 434 & 504 dated 10.10.16 & 27.04.2017 respectively, had declared the result of 15 candidates for the post of *Post Graduate Teacher (Math) (female)* in Directorate of Education under **Post code 142/2012**.

Directorate of Education vide their endorsement letter dated 07.07.2017 had informed the Board that, they have cancelled the candidature of Ms Pooja Mongia (32002420) for the post of PGT(Maths), selected under postcode 142/12 vide Result Notice No 434 dated 10.10.2016 in UR category, stating that she had expired on 15.01.2017 as per the death certificate dated 6.2.17.

The court case No 2161/16 in the matter of Anshu Tyagi vs DSSSB is still under consideration with Ld CAT. Accordingly, the candidature of the candidate having Roll number 32000428 in UR category has been proposed against the vacancy created by Ms Pooja Mongia. Further, the candidature of candidate having roll number 32002189, who was earlier kept as waitlist candidate in UR category, is now kept pending against an UR vacancy till the disposal of court case of Anshu Tyagi.

In view of above and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of PGT (*Math*) Female **Post code 142/2012**:

The selection of the above 01 Candidates shall be further subject to thorough verification of the candidature of the candidate by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority

regarding the eligibility of the candidate shall be final and binding on the candidate.

User Department shall verify the genuineness of the documents/certificates furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall also arrange to verify the correctness of the information/documents as furnished in the application forms vis-à-vis the original documents before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
