The selection of the above 03 Candidates of OBC Category shall further be subject to fulfillment of all the eligibility conditions as prescribed by the statutory RRs and terms and conditions of advertisement as indicated in the advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/ handwriting etc. on the application form, admission certificate etc. The candidature of the candidates is liable to be cancelled by the user department also, in case the candidate is found not to be fulfilling the eligibility conditions or due to any other genuine reason. The Competent authority of the department concerned shall issue the appointment letter to the candidate after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information/documents/caste certificate furnished in the application forms.

In this regard, it is also stated that OBC Caste Certificate issuing authority of GNCTD of Delhi has been requested to clarify/confirm as to whether Sh. Ram Kumar Gijroya, Jaswant Kumar Yadav & Kanhaiya Lal Yogi are O.B.C or not with respect to NCT of Delhi in terms of notifications issued by Govt. of NCT of Delhi in this regard vide letter no. F.No.Misc/2016/CC-I/ 3010 & 3013, F.No.Misc/2016/CC-I/ 3011-14 & F.No.Misc/2016/CC-I/ 3012-3015 all dated 22.03.2017, F.No.Misc/2016/CC-I/ 9368-69 dated 24.04.2017, D.O Letter No. F.No.Misc/2016/CC-I/ 10093, F.No.Misc/2016/CC-I/ 10095 & F.No.Misc/2016/CC-I/10094 all dated 11.05.2017, letter No. F.No.Misc/2016/CC-I/10613-14 dated 25.05.2017 and subsequent letters no. F.No.Misc/2016/CC-I/102303, F.No.Misc/2016/CC-I/102301& F.No.Misc/2016/CC-I/102302 all dated 20.06.2017. The

matter is still pending with the Revenue Department of GNCT of Delhi hence the User deptt should also satisfy itself about the genuineness and veracity of the certificates submitted by the candidates like educational qualification, especially as to whether the above candidates are OBCs with respect to NCT of Delhi in terms of relevant notifications issued by Govt. of NCT of Delhi before issuing of offer of appointment. Further, in case of the OBC candidates, it may also be verified that the candidates do not belong to creamy layer of the schedule of Govt. of India as per the DOPT notifications issued from time to time in this regard. Further, in case where two or more candidates have obtained equal marks, the User Deptt is advised to prepare seniority list according to their seniority as per date of birth of candidates.

The result has been processed keeping in view the eligibility conditions regarding educational qualifications, caste certificates (the genuineness/veracity of OBCs Certificates as to whether the candidates are OBC with respect to NCT of Delhi or not is yet to be established) etc. as per RRs and terms & conditions published in Advertisement as on cut-off date i.e. 21.01.2008
