PGT Fine Art-Female In Directorate of Education, Post Code 84/20

- The DSSSB vide its advertisement no. 04/2020 dated 04/01/2020 with closing date 23/02/2020 and subsequent corrigendum dated 14/01/2020 had advertised 09 vacancies (UR-06, OBC-03) for the Post of PGT Fine Art-Female under post code 84/20 in Directorate of Education.
- The written examination (online mode in single shift) Tier-I (Technical) for recruitment in respect of this post was conducted on 17/07/2021.
- 3. Whereas all candidates were instructed vide clause 7 (viii) of the said advertisement that the educational qualification, age, experience, and other eligibility conditions against the post shall be determined as on the closing date of online submission of application.
- 4. Whereas all candidates were informed vide clause 5 (ii) of the said advertisement that Candidates who wished to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificates (SC/ST/OBC/Non Creamy layer/PH/Educational/Experience, etc.) issued by the competent/notified authority (in prescribed format) on or before the cutoff date (closing date of Advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise.
- 5. On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll Nos. in respect of the above mentioned post code have been found to be 'Not Eligible' in terms of the advertisement no. 04/2020 dated 04/01/2020 and Recruitment Rules for the post of PGT Fine Art-Female under post code 84/20 in Directorate of Education, GNCTD. Therefore, the candidature of the candidate is rejected in OBC category
