Subject:- Declaration of Result of Driving Skill Test held on 17.02.2021 & Uploading of e-dossier from the shortlisted candidates for the Post of Driver (Male) Heavy Motor Vehicle under Post Code-72/12 in Department of NCC – regarding.

The DSSSB vide its advertisement No. 02/12 had advertised **07 vacancies (UR-06, OBC-01 including EXSM-01)** for the post of **Driver (Male) (Heavy Motor Vehicle), Post Code-72/12 in Department of N.C.C.** The written examination in offline mode was held on 03.11.2019.

- 2. The marks obtained by **15 candidates** duly appeared in examination conducted **on 03.11.2019** have already been uploaded on the Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 3. Further, as per Recruitment Rules for the post code-72/12, Driving Skill Test of the qualified shortlisted candidates was held on 17.02.2021 who appeared and qualified in the written examination. Accordingly, on the basis of Driving Skill Test, the following candidates having roll numbers given below have qualified the Driving Skill Test for the post of Driver (Male) Heavy Motor Vehicle, Post Code-72/12 in Deptt. of NCC held on 17.02.2021:-

Based on the performance in the written examination held on 03.11.2019 as well as Driving Skill Test held on 17.02.2021, **two (**02) candidates are being provisionally shortlisted and accordingly, allowed to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

- module in OARS link in his individual account in OARS module. Short listing of candidates is being made on the basis of marks obtained in Tier-I written examination (Objective-MCQ) for 200 marks & Driving Skill Test in qualifying nature.
 - 7. Kindly note that the e-dossier link will be activated to only those candidates who qualified in Driving Skill Test held on 17.02.2021 and are in the consideration zone of selection.
 - 8. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground.
 - 9. The e-dossier link shall be activated for a period of 15 days w.e.f. 08.03.2021 to 22.03.2021.
 - 10. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 15.06.2012 as per Advertisement No. 02/12. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. (as an additional facility). If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
 - 11. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
