## RESULT NOTICE 25/ WARDER (POST CODE NO 013/08) OFFICE OF THE DIRECTOR GENERAL OF PRISIONS

The Board vide corrigendum dated 04.10.2010 to result notice no 80 dated 26.02.2010, has debarred the candidature of Shri Krishan. The candidate Shri Krishan filed an O.A. No.65/2011 against the decision of the Board. The Ld. CAT while disposing the said OA issued the direction "with the direction to the respondents to proceed afresh in the matter and pass final orders after putting the applicant to notice and giving him chance to prove his innocence by permitting him to bring on record such material as may be relevant, and the opinion of handwriting and finger print expert. In compliance of Ld. CAT order, the case of the candidate was sent to FSL to examine his handwriting taken in the Board and as put up in the examination related documents. The FSL in his report dated 13.03.2014 found that all the red enclosed writings stamped and marked Q7 to Q34 & S7 have been written by one & the same person. Hence, the possibility cannot be ruled out that the red enclosed signatures stamped and marked Q1 to Q6, S1, S3, S4 & S11 to S22 could have been written by one and the same person. Accordingly, keeping in view of the report of FSL, the debarment order dated 27.09.2010 in respect of Shri Krishan is hereby withdrawn and the candidature of Shri Krishan is hereby revived and he is declared selected provisionally to the post of Warder Post Code -013/08 in the Office of the Director General of Prisons, Government of NCT of Delhi on the basis of performance of the candidate in written competitive examination (Descriptive) held on 14 .11.2009 and consequent upon qualifying Height and Chest Measurement / Hurdle Race test conducted on 22.02.2010 at BSF Camp, Chhawla, Najafgarh, New Delhi in the pay scale of Rs 3050-4590 (Prerevised) as per particulars below:-

The selection/appointment of above mentioned candidate shall further be subject to outcome of any court case filed by any of the candidates whose candidature has been cancelled.
