The user department shall also get the OBC certificate verified from the issuing authority before his appointment. Further, as per order of Hon'ble High Court it may also be verified that the candidate does not belong to the person/section (Creamy Layer) mentioned in column 3 of the schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt.(Res) dated 09.03.2004 and O.M. No.36033/3/2004-Estt.(Res) dated 14.10.2008.
