DECLARATION OF RESULT OF WRITTEN EXAMINATION QUALIFYING CANDIDATES IN EXSERVICEMAN CATEGORY FOR APPEARING IN PHYSICAL ENDURANCE TEST FOR THE POST OF IMATRON(FEMALE) UNDER POST CODE 36/13, WARDER (MALE), UNDER POST CODE 37/13 & ASSISTANT SUPERINTENDENT, UNDER POST CODE 38/13 IN THE OFFICE OF THE DIRECTOR GENERAL PRISONS, GNCT OF DELHI.

DSSSB conducted combined examination for recruitment to the post of Matron (female) under post code No.36/13, Warder (Male) under post code 37/13 on 02.03.2014 and Assistant Superintendent under post code No.38/13 on 09.3.2014. Based on performance of the candidates in written examination, vide result notices no. 275 (for Matron) )(Female) total 162 (UR-82,OBC-44,SC-24 & ST-12) 276 (For Warder) (Male) total 1062 candidates (UR-542, OBC-284, SC-158 and ST-78)and 280 (for Assistant Superintendent) total 74 candidates (UR-39, OBC-20, SC-11 and ST-04) have already been declared qualified provisionally and eligible to be called for the Physical Endurance Test, subject to their fulfilling all conditions of eligibility and also correctness of the information furnished by the candidates in the OARS (ONE LINE APPLICATION REGISTRATION SYSTEM).

Now in continuation to earlier notices no. 275, 276 and 280, and on the basis of clarification provided by Office of the Dte. General of Prison, Nil candidate in ex-Servicemen Category for the post of Matron under post code No.36/13, 41 candidates in Ex-Serviceman Category for the Post of Warder Post Code 37/13 and 08 candidates in Ex-Serviceman Category for the Post of Assistant Superintendent Post Code 38/13, are being declared eligible for Physical Endurance Test to be conducted for the post of Matron, Warder and Assistant Superintendent Jail.

Ex-Serviceman candidates have been shortlisted for appearing PET on the basis of details provided by them in OARS. Since documents have not been called from the candidates along with application, as such detail scrutiny regarding their eligibility has not been carried out and therefore mere inclusion of name in the list for qualifying candidates for appearing in the Physical Endurance Test does not entitle the candidate the right over the post.

The candidates short-listed for appearing PET is purely provisional subject to the verification of credentials, for determination of eligibility for the posts to be carried out by the Board after completion of PET. Final selection against advertised vacancies shall be made in accordance with the merit list drawn as per result of written examination subject to availability of vacancies and the candidates qualifying the Physical Endurance test and also fulfilling of all conditions of eligibility as prescribed by the RR's and term and conditions of advertisement.

Candidates whose roll numbers are indicated in the result notice will be called for Physical Endurance Test separately.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions if any detected at any stage.

The result notice is issued as per the approval of the Competent Authority, DSSSB.
