PROVISIONAL SELCTION OF CANDIDATES FOR APPEARING IN SKILL TEST (STENOGRAPHY/SPEED TEST) UNDER POST CODE 91/09 (STENOGRAPHER GRADE-III (SERVICES DEPARTMENT)), 92/09 (JR. STENOGRAPHER (DELHI JAL BOARD), 41/13(STENOGRAPHER, GRADE-III (SERVICES DEPARTMENT), 50/13 (STENO-TYPIST (MCD)) AND 59/13 (JR. STENOGRAPHER (D.A.M.B)).

DSSSB conducted a combined examination for recruitment to the post of Stenographer Grade-III (Services Pepartment)/ Jr. Stenographer (Delhi Jal Board /Stenographer, Grade-III(Services Department)/Steno-typist (MCD)/Jr. Renographer(D.A.M.B) respectively under post code 91/09, 92/09, 41/13, 50/13 and 59/13 on 27.07.2014. On the basis of performance of the candidates in written examination, result of shortlisted candidates for Skill Test, was declared vide Result Notice No. 297 dated 25.02.2015 and same was uploaded on the web-site of the Board.

It was noticed by the Board that due to offline application format and online application format of calling applications for these post codes, some candidates could not be identified as common candidates and thus could not be considered either in offline post codes i.e. 91/09, 92/09 or online post codes i.e. 41/13, 50/13 and 59/13. Now on the basis of some representations received in this regard, the data processing, common candidates, as per annexure-I, have now been considered provisionally for skill test for these posts.

The selection of the candidates as per annexure-I is provisional and subject to verification of their applications in these posts codes, eligibility as per terms and conditions of advertisement and recruitment rules for the posts.

The list is Roll number wise and does not reflect the merit position of the candidates. The candidates shortlisted for appearing skill test is purely provisional subject to the verification of credentials, for determination of cardinality of the posts will be carried out by the Board after completion of Skill test.

Reserved category candidates short-listing in UR category in written examination and obtained marks above or .qual of last qualified UR candidate and have not availed any benefit of reservation, have been declared qualified for opearing in Skill test against UR vacancies and their final selection to the post shall be considered in UR category subject to availability of vacancies, otherwise in their respective category if eligible otherwise for selection in the said category.

Mere inclusion of name in short-listed candidates does not confer any right of candidate over the post. The final selection will be carried out at the time of final selection after Skill Test (Stenography/Typing Speed) on obtaining documents of candidates. At any stage of recruitment, if any wrong or misleading information is noticed by the Board in respect of any candidate his/her candidature will be liable to be rejected.

As at this stage, short listing of candidates have been done on the basis of information in master data and position in merit list, thus all reservation and concessions given to candidates in reserved categories are purely provisional and extent of such reservations or concession will only be verified at the time of final selection for these post.

Candidates whom roll number are indicated in the result notice will be called for Skill Test (Stenography/Typing Speed) separately.

The result notice is issued with the approval of the Competent Authority, DSSSB.
