Session Judge, letter dated 10.5.2013 issued by Spl, Secretary (Services) regarding reservation policy to be followed by with regard to SC/STs in the civil posts under GNCTD. The OBC category candidates with

certificate of Delhi Origin issued by the Competent Authority of Govt. of NCT of Delhi only have been considered for admissibility of benefit of reservation. In respect of some OBC candidates who had obtained the OBC certificate recently but whose education is from other states, their selection in OBC category is being processed subject to the verification of their cast certificate by the user department

Further candidature in respect of roll nos.05510960 in UR category, 05512280 in OBC category & 05514052 in SC category to the post of TGT(Maths) male under the post code No.55/10 are being kept pending for completion of documents and their result be declared in due course.

The selection of the above 05 candidates (SC-1) TGT (Maths) Male under the post code No.55/10 & (UR/PH-1,OBC-1 & SC-2) TGT (Maths) Female under the post code No.56/10 shall further be subject to candidate's fulfilling the eligibility conditions of the post, as prescribed by the statutory Recruitment Rules and terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of their identity with reference to their photograph, signatures and handwriting etc., on the application form, admission certificates etc. The candidature of the candidate is liable to be cancelled by the user Department also, in case candidate is found not fulfilling the eligibility conditions or any other genuine reason. The Competent Authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
