Teacher (Primary) URDU, MCD shall further be subject to fulfillment of all the eligibility conditions as prescribed by the statutory RRs and terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of his identity with reference to his photograph, signature/handwriting and thumb impression etc. on the application form, admission certificates etc. The candidature of the candidate is liable to be cancelled by the user department also, in case the candidate is found not be fulfilling the eligibility conditions.

The Competent Authority of the department concerned shall issue the appointment letters to the candidate after satisfying itself of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information/documents as regard age, qualification, caste certificate etc. as furnished in the application form. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The user department shall also get the OBC certificate verified from the Issuing Authority before the appointment. Further, it may also be verified that the candidate does not belong to the persons/sections (Creamy layer) mentioned in column 3 of the Schedule of Govt. of India, Department of Personal and Training O.M. No. 36012/22/93-Estt (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt (Res.) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt (Res.) dated 14.10.2008.
