NOTICE

Whereas the DSSSB vide advertisement No. 04/2020 dated 04/01/2020 had advertised 692 vacancies (UR-249,EWS-27, OBC-253, SC-84,ST-79) for the post of Physical Education Teacher post code 87/20 in Directorate of Education, GNCT of Delhi.

The opening date of application was 24/01/2020 and closing date of application was last date of receipt of application form i.e. 23/02/2020.

Whereas the online written examination for the post of Physical Education Teacher was held on 02/08/2021. The examination was of 200 marks (objective). As per advertisement 04/2020 the part –I is of 100 marks. Part-I is has five sections 20 marks each which are (i) General Awareness (ii) General intelligence and reasoning ability (iii) Arithmetical & Numerical ability (iv) Test of Hindi Language & Comprehension.

The Part-II is also of 100 marks (objective one marks each) from subject concerned including question on teaching methodology. All candidate have to pass both part-I & part-II separately for being considered qualified.

The merit of the candidates have been prepared on the basis of marks scored above or equal to qualifying marks in each Part (Part-I & Part-II separately) in his/her respective category as per advertisement no. 04/2020.

The authorized examination conducting agency of DSSSB provided marks list in two forms:- one is combined merit list (having total marks of Part –I & Part-II collectively of all candidates who appeared in the exam) and other each category wise merit list having marks of Part-I & Part-II separately.

The marks were declared on OARS module on 02/11/2021 after merging combined merit list with category wise merit list to get part-I & part-II marks of each candidate in main combined merit list from which the marks Part-I & Part-II were uploaded in OARS module for viewing of the candidates. The candidates from reserve category having higher

marks are usually placed in the unreserved category as per own merit in addition to their name in their respective category. Thus there is a probability of duplicate entry of one name in combined merit list which need to be removed. For this purpose the duplicate names, Roll No. & marks removed from the combined marks list by using duplication software.

However, while preparing list of shortlisted candidates fror uploading of e-dossier, it was self detected at DSSSB level that marks of some candidates were not matching with the marks shown in actual marks list provided by the examination conducting approved agency.

Accordingly the marks uploaded in OARS were immediately withdrawn on the same date i.e. 02/11/2021 after self-detecting the technical fault.

The IT Branch of DSSSB was consulted and after analysis, it was found that there was software glitch in de-duplication process of marks, Roll No. & Names of candidates and marks were overlapped making the mark list faulty.

Whereas the technical glitch was identified and correct marks list of all 9018 candidates were uploaded in OARS module within a few hours on 02/11/2021 itself.

Now, after rectifying the unintentional, bonafide technical glitch, a total of 858 qualified candidates were shortlisted and asked to upload edossier during the period 08/11/2021 to 22/11/2021.

This public notice is for information of all candidates for the post of Physical Education Teacher, Post Code 87/20 and all concerned.
