In compliance of Ld. CAT order dated 07.09.2016 in OA No. 3925/2015 in the matter of Ms. Kavita Rani V/s GNCTD & ors. and in view of Hon'ble High Courts Judgment dated 07.08.2013 in WP(C) 1520/2012 in the matter of Sachin Gupta, the candidature of Ms. Kavita Rani which was earlier rejected on the ground of not having passed Hindi as a subject at Secondary Level vide order No. F.1(151)/CC-II/DSSSB/08/Pt.-II/7740-46 dated 21.08.2014 is hereby reconsidered. On the basis of merit list of written examination (part-II) held on 15.06.2008, the candidate whose details are mentioned below is hereby provisionally selected to the post of Teacher (Primary) in Municipal Corporation of Delhi under post code 165/07 in OBC category in the Pay Scale of Rs. 4500-7000 (Pre-revised).

The selection against advertised vacancies in post code 165/07 was processed by the Board and result was declared vide result notices dated 25.09.2008, 07.01.2009, 17.04.2009 as per merit drawn on the basis of Part-II examination (Descriptive) held on 15.06.2008. The vacancies for the post of Teacher (Primary), MCD were advertised by the Board as per requisition of Municipal Corporation of Delhi vide advertisement No. 08/2007 with closing date of receipt of application as 29.10.2007.

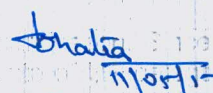
The selection of the above 01(one) candidate under OBC category shall be further subject to through verification of the candidature of the candidate by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidate Ms. Kavita Rani was shortlisted in UR category in Part-I examination. Since in Part-II examination she was having marks less than that of the last selected candidate of UR category, therefore she has been selected in OBC category. The User department shall also check her eligibility for availing reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application form vis-a-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate to the post of Teacher (Primary), post code 165/07.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any time.
