**RESULT NOTICE 743**

**LIBRARIAN IN DIRECTORATE OF EDUCATION  
UNDER POST CODE 163/2007**

1. The DSSSB vide its advertisement number 07/2007 with closing date 29.10.2007 had advertised 39 vacancies (UR-20, OBC-15, SC-03 & ST-01 including OH-01 and VH-01) for the post of Librarian in Directorate of Education under Post code 163/07 in the pay scale of Rs. 5500-9000/-(Pre- revised). Board had conducted Part-I examination under old examination scheme for recruitment to this post on 18.01.2009.

2. The result for the postcode 163/07 was not declared earlier as it was initially informed by the Directorate of Education letter dated 13/03/2009 to keep in abeyance the anticipated vacancies for 2007-08 & 2008-09 till the appointment process for the selection of 87 posts (postcode 17/07) is completed. Since 39 vacancies were advertised under the post code 163/07, accordingly DSSSB did not process the result for post code 163/07. Later Directorate of Education has included the 39 vacancies in their subsequent requisitions.

3. Ld CAT vide order dated 21.07.2014 in O.A. No. 926/13 in the matter of Richa Gupta vs DSSSB & Anr has directed the DSSSB to finalize the selection process of postcode 163/07. DSSSB had filed appeal against the Ld CAT order dated 21.7.2014 in Hon'ble High Court vide WP(C) No. 1504/2015 titled as DSSSB & Anr. Vs. Richa Gupta. During the hearing of the writ petition Directorate of Education has stated before the Hon'ble High Court that 39 posts of Librarian advertised vide post code 163/07 can be adjusted by them against present vacancies, if DSSSB is in the position to declare the result. Accordingly Hon'ble High Court vide judgment dated 20th March 2017 in WP (C) No. 1504/2015, DSSSB & Anr. Vs. Richa Gupta dismissed the appeal. Further Hon'ble High Court vide judgement dated 21.03.2017 in the matter titled Ashok Kumar vs Chief Secretary, GNCT of Delhi and ors. bearing WP(C) No. 1826/2016 has decided the petition in view its earlier order dated 20.3.2017.

4. Accordingly in pursuance of above referred judgments and Directorate of Education's letter no. DE.4/1/(340)/E-IV/Court



Case/2012/10159-10160 dated 12.07.2016, No. DE.4/1/(340)/E-IV/Court Case/2012/2173 dated 09.06.2017 and No. DE.4/1/(340)/E-IV/Court Case/2012/4141 dated 24.10.2017, DSSSB has initiated the selection process for postcode 163/07.

5. DSSSB vide Result Notice No. 711/CC-I dated 24.09.2018 has shortlisted 416 candidates for the post of Librarian in Directorate of Education under post code-163/07 for evaluation of their Part-II examination descriptive answer sheets. Board had conducted Part-II examination under old examination scheme for recruitment to this post on 18.01.2009.

6. The mark list of Part-II examination for the post of Librarian in Directorate of Education under post code-163/07 of 402 shortlisted candidates out of 416 shortlisted candidates has been declared vide notice number 741 dated 16.11.2018.

7. The marks of Part-II examination of the remaining 14 shortlisted candidates having roll number -**1710468, 1711104, 1711320, 1713029, 1713069, 1810014, 1810046, 1810080, 16310001, 16310008, 16310037, 16310038, 16310045, 16310047** have not been declared as their Part-II examination answer sheets for postcode 163/07 are not available/traceable being old record. The preference of claim for postcode 163/07 has been called separately. Further, out of 14 candidates, 06 candidates belong to OBC category, to consider the probability of selection of these 06 OBC candidates in final selection in OBC category, we may keep the 06 OBC vacancies as withheld. In SC category there is only one SC candidate out of 14 candidates. As such 16 vacancies (UR-07, OBC-06, SC-01, OH/UR 01) have been kept withheld till the finalization of their claim.

8. On the basis of the merit list of Part- II examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement and Hon'ble High Court judgement dated 25.09.2017 in WPC No. 6131/17 in the matter of DSSSB & Ors vs Vijeta Kundu & Ors, the following candidate is provisionally selected to the post of Librarian in Directorate of Education under Post code 163/07. **DSSSB has however not undertaken any veracity/scrutiny of experience certificate or certification in computer application being technical in nature, therefore User Department must ensure the eligibility of the candidate in terms of Experience of 2 years in a Library/computerization of a Library or 1 year certification in computer application from a recognized Institute or equivalent as per the RRs and the correctness**



**of the experience certificates/Computer certificates furnished by the candidate at their own level.**

11. In view of remarks mentioned against the candidate having roll number **17112619** the selection of the candidate is purely provisional subject to the satisfaction of the user department regarding consideration of the experience of 2 years in a Library/Computerization of Library as on cut off date. Further since candidate has furnished the OBC(Delhi) certificate dated 02.01.2007 and as per the information of the candidate in his application form and documents furnished – his place of Birth is in Uttar Pradesh, also place of his residence, Institutions where he had attained all his qualifications since 10th onwards and the institutions where he had undertaken experiences are from Uttar Pradesh, therefore the admissibility of the reservation benefit under OBC category is also purely provisional subject to the satisfaction and verification of the admissibility of the OBC reservation benefit in Govt of NCT Delhi and OBC certificate by the user department itself prior to the issue of offer of appointment to the candidate concerned.

16. Out of advertised 01 vacancy under OH category, 01 vacancy has been withheld for the 01 UR/OH candidates whose part-II answersheets is not available.

17. **List of candidate against vacancies under VH Category**

18. No VH candidate was found. One UR vacancy has been kept unfilled for returning to the user department, for carry forward of unfilled VH category vacancy as per DOPT norms.

19. As the Board had conducted a combined exam for the post of Librarian for the post codes 17/07 (Dte of Education), 182/07 (H&FW), 163/07(Dte of Education) & 30/08 (MAIDS) on 18/01/2009, as such the meritorious candidates who have already been selected in postcodes 17/07, 182/07, 182/07 and 30/08 has not been again reconsidered for selection in postcode 163/07.

20. The minimum qualifying marks criteria adopted in post codes 17/07, 83/07, 30/08, 182/07 and 183/07 has been made applicable in the post code 163/07 also. The minimum qualifying marks for selection for the post are 45% in UR category and 35% for other reserved categories.

21. The candidature of candidate having roll number **16310656** is rejected being not eligible to the post as the candidate has not furnished details of the computer course or experience in his application form, or has not attached any documents related to them.

22. The candidature of the candidates having roll number **16311189, 16310643, 16310491, 16311080, 1710057, 16311113, 1711775, 16310612, 16311286, 16310291, 16310312, 16311239, 16310794, 16311597** have been rejected as they are OBC Outsider and not entitled for seeking reservation benefit under OBC category in Delhi.

23. The candidature of candidates having roll number **1712153, 1711969, 1711839, 1710007** in UR category; **1712718, 16310767, 1711845, 1711783, 1711631, 1710910** in OBC category and **1712910, 1711212** in SC category have been kept as pending for seeking the application form and requisite documents from the candidate concerned for determining their eligibility.

24. The candidature of candidates having roll number **16310131** in UR category and **16311085** in OBC Category are kept as pending for seeking additional documents regarding the tenure of computer course as the same is not clear from the documents provided by them.

25. The candidature of candidates having roll number **1713019** is kept as





pending in UR category for seeking additional documents regarding her experience.

26. The selection of the above **08** Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. **All these selection is purely provisional subject to admissibility of the experience details / Computer Certificates furnished by the candidate in reference to the provisions as prescribed in the RRs for the post by the User Department in view of the Hon'ble High Court judgement dated 25.09.2017 in WPC No. 6131/17 in the matter of DSSSB & Ors vs Vijeta Kundu & Ors.**

27. **DSSSB has however not undertaken any veracity/scrutiny of experience certificate or certification in computer application being technical in nature. The same have been mentioned against the name of each candidate. Therefore User Department must ensure the eligibility of the candidate in terms of Experience of 2 years in a Library/computerization of a Library or 1 year certification in computer application from a recognized Institute or equivalent as per the RRs and the correctness of the experience certificates/Computer certificates furnished by the candidate at their own level.**

28. Candidature of candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate

29. The User department shall check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates, including the detailed verification of OBC certificate of candidate having roll number 1712619.

30. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the Degree, Degree/Diploma in Library Science and requisite experience/Computer Course. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

31. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

32. **While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.**
