1. The DSSSB vide its advertisement No. 01/2015 with closing date 26.11.2015 had advertised 20 vacancies (UR-15, OBC-03, ST-02 including 07- EXSM) for the post of Matron under postcode 63/15 in Directorate General of Prisons. The Board had conducted Physical Endurance test (PET) for the applicants of the postcode on 19.11.2018, 20.11.2018, 22.11.2018, 26.11.2018, 27.11.2018, 28.11.2018 and 30.11.2018 at Sports Complex, East Vinod Nagar (Mayur Vihar Phase-II), Near Neelam Mata Mandir, Delhi-110091.

2. In the PET conducted out of 6243 candidate only 539 appeared for PET. Further from the 539 present candidates only 159 could qualify the PET.

3. In postcode 63/15 no vacancy has been advertised for SC category, as such SC candidates who have applied for the post shall be considered against the UR vacancies, in case they fulfill the norms required under UR category. The candidate having roll number 2820002683 (Basanti) who belongs to SC category is overage in UR category and has qualified PET, is not eligible for shortlisting for written examination in UR category.

4. On qualifying PET, following 158 candidates having roll numbers are provisionally allowed to appear for written examination for postcode 63/15, subject to correctness of the information furnished by the candidates in their online application forms:
