Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. While getting the Caste Certificates verified from the issuing authority, it should be invariably ensured that the candidates claiming benefit under OBC category do not fall under creamy layer as per the latest instructions of the Govt. of India in this regard. It is further clarified that the eligibility regarding knowledge of

Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.
