CAT dated 30.01.2012 as passed in TA 23/2011 case titled – Veena Kumari &orsVs DSSSB&Anr. read with the order of Hon'ble High Court in W.P(C) 1641/2011, titled DSSSB&ors vsPreeti Rathi&Ors., the candidates with following particulars have been provisionally selected to the post of Teacher Primary in Municipal Corporation of Delhi in the Pay Scale of Rs. 4500-7000 (Pre-revised) under post code 165/07.

The selection against advertised vacancies in above post code was processed by the Board and result was declared vide result notices dated 25.09.2008, 07.01.2009 and 17.4.2009 as per merit drawn on the basis of Part-II examination (Descriptive) held on 15.06.2008. The vacancies had been advertised by the Board as per requisitions of Municipal Corporation of Delhi vide advertisement No. 08/2007 with closing date of receipt of application as 29.10.2007.

The selection of the above 15(Fifteen) (UR-08, OBC-05,SC-02) candidates shall further be subject to fulfillment of all eligibility conditions as prescribed by the statutory RRs & terms and conditions of advertisement as indicated in the advertisement inviting applications and direction of Hon'ble High Court ,Ld.CAT and also subject to thorough verification of their identities with reference to their photographs, signatures, handwriting etc. on the application forms, admission card, attendance sheet etc. by the User Department. The candidature of the candidates is liable to be cancelled by the user Department also, in case the candidates are not found fulfilling the eligibility conditions or any other genuine reasons. The competent authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. ***Further, in particular, the user department i.e. MCD will ensure the eligibility with regard to age relaxation to be allowed to each candidate as per the service rendered as contractual teacher as on 29.10.2007 as per direction of Hon'ble High Court in Para 13&14 of the order in W.P.(C) 1641/2011 on which present TA relied before offer of appointments.*** The selection/appointment of above mentioned candidates shall further be subject to outcome of any court cases filed by any of the candidates whose candidature has been cancelled. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

Further, the result of Ms. Shilpa, Roll Number 16418374 and Sh. Naresh Kumar,16414270 the petitioners in the above TA is not declared as they have informed that they have got Govt. job in Delhi Govt. and Haryana Govt. respectively and not interested in the post of Teacher Primary (MCD).The order of Ld. CAT in present TA in respect of these two may be treated as complied.

The result of Ms. Geeta Arya, Roll Number 16416552, is not declared since she does not fulfill the eligibility condition of RR for the post of having 50% marks in Senior Secondary Examination as she has obtained 46% marks in Senior Secondary Examination and being SC Migrant the benefit of relaxation of 5% marks in pass percentage in Senior Secondary Examination given to SC candidates for the post at time of processing the result initially on request of user department and corrigendum to advertisement, issued to this effect by the Board on 28/29/10/2007 is now not admissible to her in the light of judgment dated 4.8.2009 of Hon'ble Supreme Court of India as passed in Civil Appeal No. 5092 of 2009 arising out of Petition(s) for Special Leave to Appeal (Civil No(s) 24327/05 – Subhash Chandra & Anr.Vs DSSSB&ors with WP (C) no 507 of 2008 – Sarv Rural and Urban Welfare Society Vs U.O.I and Ors. The selection/appointment of above mentioned candidates shall further be subject to outcome of any court cases filed by any of the candidates for the above said post.

With this Result Notice the order of Ld. CAT may be treated as complied in respect of the all petitioners in TA 23/2011.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any.
