It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.

Further, Roll No. 54001074, 54000937 & 54100961 mentioned above in UR category stands deleted from the Result Notice No 47 dated 27/07/2016 due to shifting of these candidates from SC category to UR category as per their merit.

No. 100/3067/2016, appointments, if any, made by respondents will be subject to the outcome of the above said O.A.
