RESULT NOTICE
FIRE OPERATOR (POST CODE -003/09)
DELHI FIRE SERVICES, GNCTD

This is in pursuance to the directions of the Ld. CAT vide its orders in (i) OA No.3717/2011 titled Sanjay Vs GNCTD & Ors. (ii) OA No.2876/2011 titled Sunil Mann Vs GNCTD (iii) OA No. 2804/2011 titled Arun Kumar Vs GNCTD (iv) OA No. 3149/2011 titled Sunil Kumar Vs GNCTD & Ors. (v) OA No. 2802/2011 and 2803/2011 titled Sanjiv and Sanjeev titled Sanjay Vs GNCTD & Ors.

The brief facts of the present cases are that the applicants had applied for the post of Fire Operator, Post Code 003/09 they were declared qualified in written tests, Physical Endurance Test (PET) and Driving Skill Test. However, the candidature of the applicants were rejected on the basis of the report of verification committee and they were further debarred for a period of five years w.e.f. 01-09-2009 i.e. from the following month in which the aforesaid written examination was held. The applicants filed O.A's before the Ld. CAT against their rejection and debarment by the Board vide above mentioned cases. In compliance of the directions of the Ld. CAT, the Board sent the dossiers of the applicants to the FSL, GNCTD for obtaining opinion for ascertaining genuineness of the candidates/applicants in the said examination.

Now, after obtaining the opinion from the FSL, GNCTD, the applicants/candidates are hereby provisionally selected and recommended for appointment to the post of Fire Operator, Post Code-003/09 in the Delhi fire services., in the pay scale of Rs. 4000-100-7100 (Pre-revised).

The result has been processed keeping in view the eligibility conditions regarding educational qualification/caste certificate as on cut-off date i.e. 03.03.2009.

The user department shall also get the OBC certificate verified from the issuing authority before his appointment. Further, it may also be verified that the candidate does not belong to the persons/section (Creamy layer) mentioned in column 3 of the Schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt.(Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt.(Res)dated 14.10.2008.
