## RESULT NOTICE (PART-II) NURSE "A" GRADE, (POST CODE-21/13) MUNICIPAL CORPORATION OF DELHI

In continuation of Result Notice (Part-I) vide office order No. 349 dated 30.12.2014 on the basis of written examination held on 09/06/2013 and eligibility regarding educational qualification, age etc as per Advertisement No. 01/13 and RRs for the post of Nurse "A" Grade, (Post Code-21/13) in MCD, the following candidates are provisionally selected and recommended for appointment to the post of Nurse "A" Grade, (Post Code-21/13).

The verification & collection of documents were carried out by the staff deployed from the H&FW Deptt and thereafter the collection of documents were carried out by the staff of DSSSB at Board's office on 22/05/2014, 23/05/2014, 02.09.2014, 22.09.2014 & 23.09.2014 for the pending, absentee, OBC(D), EXSM, OH(OL) candidates etc.

As per decision of Board, based on the clarification received from the services Department, Govt. of NCT of Delhi all such candidates whose result was withheld for the reason that they belong to SC/ST (outsider) category are eligible for reservation to the post, which are reserved for SC/ST candidates. Therefore, their result is being declared as per the current policy on reservation dated 10/05/2013 based upon case of Deepak Kumar (WPC No. 5390/2010). They are provisionally selected subject to fulfilment of all other conditions as described in RRs provided by the User Department as on cut-off date.

<u>POST CODE 21/13</u>:- The Board is declaring the part-II result of following SC/ST candidates alongwith others pending candidates is being declared, for the Post code 21/13 of 45 candidates (SC-32 & ST-14). Result of 01 ST candidates are kept pending. On the basis of eligibility criteria and other terms & conditions of RRs of the user deptt, i.e. MCD, the following candidates are hereby provisionally selected and pending result of the remaining candidate and waiting list will be declared later on. If any, essential qualification is not as per the provisions of the RRs, the candidature of the candidates are liable to be cancelled by the User Department. The Competent Authority of the department concerned shall issue the appointment letter to the candidate after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information/documents/caste certificate furnished in the application forms. Further, the recognition of the universities/institutes from where the degrees/diplomas/certificates have been submitted by the candidates should also be verified by the User Department. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.
