For admissibility of benefit of reservation, the result has been processed as per the judgment of Hon'ble Supreme Court of India dated 04.08.2009 as passed in Civil Appeal No. 5092 of 2009 arising out of Petition (s) for Special Leave to appeal (Civil) No.(s) 24327/05-Subhash Chandra & Ors, Vs DSSSB & Ors. and there being no Presidential notification under article 342 of the Constitution for STs in the UT of Delhi, the candidature of ST candidates for admissibility of benefit of reservation for the post has accordingly been rejected.
