Subject:- Declaration of Result of Driving Skill Test held on 17.02.2021 & Uploading of e-dossier from the shortlisted candidates for the Post of Driver (Male) under Post Code-73/12 in Deptt. of NCC-regarding.

The DSSSB vide its advertisement No. 02/12 had advertised **03 vacancies (UR-03 including 01 EXSM)** for the post of **Driver (Male)**, **Post Code-73/12 in Deptt. of NCC**. The date of opening of application for was 15/05/2012 with closing date of 15.06.2012. The written examination in offline mode was held on 20.10.2019.

- 2. The marks obtained by **20 candidates** duly appeared in examination (offline) conducted **on 20.10.2019** have already been uploaded on the Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- **3.** Further, as per Recruitment Rules for the post code-73/12, Driving Skill Test of 03 qualified shortlisted candidates was held on **17.02.2021** who qualified in the written examination. Out of which only 02 candidates having roll number given below have qualified the Driving Skill Test for the post of Driver (Male), Post Code-73/12 in Department of NCC held on 17.02.2021:-

- 4. The candidate having **Roll No. 5110000002** found <u>disqualified in Driving Skill Test</u> held on venue & date mentioned above and accordingly, his candidature is rejected for the post of Driver (Male), Post Code-73/12 in Department of NCC.
- **5.** Based on the performance in the written examination held on 20.10.2019 as well as Driving Skill Test held on 17.02.2021, **two (**02) candidates are being provisionally shortlisted and accordingly, allowed to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
- **6.** The category wise cutoff marks (who qualified Driving Skill Test) for uploading e-dossier have been given as under:-

- 7. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards/Driving License etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module. Short listing of candidates is being made on the basis of marks obtained in Tier-I written examination (Objective-MCQ) for 200 marks & Driving Skill Test in qualifying nature.
 - 8. Kindly note that the e-dossier link will be activated to only those candidates who qualified in Driving Skill Test held on 17.02.2021 and are in the consideration zone of selection.
 - 9. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground.
 - 10. The e-dossier link shall be activated for a period of 15 days w.e.f. 08/03/2021 to 22/03/2021.
 - 11. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 15.06.2012 as per Advertisement No. 02/12. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. (as an additional facility). If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
 - 12. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
