1. The DSSSB vide its result notice number 334 dated 26.08.2015, 423 dated 24.08.2016 and 458 dated 09.12.2016 has declared result of 38 candidates for the post of Junior Engineer (Electrical & Mechanical) in Delhi Jal Board under **Post code 14/2012**.

2. The candidature of candidate having roll number 60000498 was kept pending on account of court case having OA number 4665/14 in the matter of Sangeeta Deepak & anrs Vs GNCT of Delhi & anr. The said court cases has been decided vide Ld CAT order dated 16.12.2015. In compliance of the Ld CAT's aforesaid order the candidature of the applicant Sh Amit Kumar has been verified to the effect that he has applied manual application form for the post of Junior Engineer (Electrical & Mechanical) under postcode 14/12 vide ID number 2267279. 6. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
