
WELFARE OFFICER IN SOCIAL WELFARE DEPARTMENT UNDER POST CODE 55/2015

- 1. The DSSSB vide its advertisement number 01/2015 with closing date 26.11.2015 had advertised 06 vacancies (UR-02, OBC-02, SC-1 & ST-1) for the post of Welfare Officer in Social Welfare Department under Post code 55/2015 in the pay scale of Rs. 9300-34800/- having Grade Pay of 4200/- (Pre- revised). Board has conducted One Tier Examination (G) for recruitment to this post on 27.08.2017. Marks of 185 candidates who appeared in the examination and whose OMR sheets have been evaluated have been uploaded on Board's website vide notice number 600 dated 07.02.2018.
- 2. Based on the performance in the examination, 17 candidates were provisionally allowed to upload e-dossiers in the ratio of 1:3 of the advertised vacancies subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The e-dossier was made active wef 19.02.2018 to 05.03.2018 vide notice number 603 dated 19.02.2018. Later the e-dossier uploading date was extended upto 15.03.2018 vide notice number 605 dated 05.03.2018.
- 3. On the basis of the merit list of One Tier Examination and after preliminary scrutiny of eligibility for the post as per the provisions of the statutory Recruitment Rules of the post and the terms & conditions of the advertisement, the following candidate is provisionally selected to the post of Welfare Officer in Social Welfare Department under Post code 55/2015.

- 11. The candidature of candidate having roll number 16100644 is kept pending in OBC Category for verification of allegations leveled in the complaint received by the Board against him.
- 12. The selection of the above 04 candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 13. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing



authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

- 14. The User department shall also check the eligibility of the reservation benefit in respect of the candidates who are selected in reserved categories. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- 15. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 16. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
