1. The DSSSB vide its result notice number 472 dated 23/02/2017 has declared result of 18 candidates for the post of Post Graduate Teacher (Geography) (Male) in Directorate of Education under Post code 134/2012 in the pay scale of Rs. 9300-34800 having Grade Pay of 4800/- (Non-Gazetted).

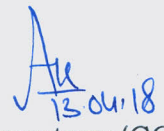

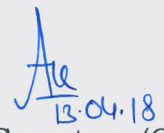
