Subject to verification of OBC certificate and creamy layer status of the candidate by user department in terms of department of Personnel & Training O.M No. 360/2/22/93-Estt (SCT) dated 08/09/93 read with its modification dated 14/10/2008.

During the course of scrutiny of the dossier of one of the petitioner namely, Ms. Monika Varun, Roll No.07727853 (D.O.B.09/12/1986) under SC category it is found that she had not enclosed SC certificate alongwith her Application form.
