- 1. This is in continuation of Notice no. 1284 dated 21.05.2021.
- The DSSSB vide its advertisement No.01/2017 had advertised total- 05 vacancies (UR-05) for the Post of Junior Engineer (Civil) under Post Code- 05/17 in DAMB.
- 3. The Tier-I examination (online mode) was conducted on **04.11.2019**.
- 4. Based on the performance in the Tier-I examination (online Mode), vide Result Notice No. 1077 dated 05.03.2020, a total of 100 candidates who obtained marks above or equal to cut-off marks in their respective categories, were provisionally shortlisted to appear in Tier-II examination, subject to the information furnished by the candidates in their online application forms.
- 5. The Tier-II examination (online mode) was conducted on **27.03.2021** and a total of **86** candidates appeared out of the above **100** candidates. The mark statements of the above post code have been uploaded on the Board's website. Candidates can view their marks by logging on to their account in OARS module on www.dsssbonline.nic.in Vide Notice No. **1284** dated **21.05.2021**.
- 6. Based on the performance in the written examination (TIER-II) being qualified, **14 candidates (UR)** were provisionally shortlisted and accordingly allowed to up-load their e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form. The e-dossier link for the said post was active from **26.05.2021 to 09.06.2021.**
- 7. The e-dossier of the candidate having following roll numbers has been found deficient as per remarks mentioned below, accordingly he is being provided opportunity to upload the deficient documents:

- **8.** The e-dossier link shall be active from **15.06.2021 to 24.06.2021.** The candidate uploading e-dossier should ensure that he fulfills all the eligibility criteria/all essential qualifications as per RRs for the said Post as on date of closing date of application, i.e. **21.08.2017**.
- The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If candidate fails to upload the e-dossier during the said period, his candidature will be rejected and no further opportunity will be given on whatsoever ground.
- Mere asking the candidate for up-loading documents in the edossier module does not confer upon him any right to selection to the applied post. Final selection will be made purely on the basis of merit (based on marks attained in Tier-II Exam) against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions.
- 11. The above short listing of candidates for calling of e-dossier for the said post will be subject to outcome of pending court cases or other cases, if any.
