**POST GRADUATE TEACHER (HINDI) (FEMALE)
IN DIRECTORATE OF EDUCATION
UNDER POST CODE 137/2012**

1. The DSSSB vide its result notice number 584 dated 22.12.2017 has declared the result of 63 candidates for the post of *Post Graduate Teacher (Hindi) (Female)* in Directorate of Education under **Post code 137/12**.

2. One post in UR category was earlier kept withheld in view of pending court case in the matter of Reena Choudhary vs GNCTD in OA No 2178/15; similarly two posts were withheld in OBC category in view of pending court case in the matter of Anita & Anrs Vs DSSSB in OA No 2225/15; and two posts were withheld in SC category in the matter of Raju Singh & Others vs GNCTD in OA No 2420/15 & in the matter of Rachna Vs GNCTD in OA No 2139/16. As the applicants of these cases namely Reena Choudhary, Anita, Arti Saini, Promila Bhoria and Rachna are less than the marks of last candidate in consideration zone in their respective category, as such the vacancies withheld are hereby released. However the marks of the applicants are kept in sealed cover in compliance of their Ld CAT order.

3. On the basis of the merit list of Tier- II examination, additional documents furnished by the candidates whose candidatures were pending and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Hindi) Female **Post code 137/2012**:

8. The candidature of the candidate having Roll Number 22000039 is kept pending in VH/UR category for consideration of her representation further candidature of candidate having Roll no 22000170 is still pending for want of her disability certificate.

9. The selection of the above 13 Candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

10. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

11. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

12. **Further, the above selection is subject to outcome of cases titled Anil Kumar Vs GNCTD in OA No 4114/17 and Dinesh Kumar Vs GNCTD in OA No 186/18.**
