- 1. The DSSSB vide its result notice number 585 dated 22.12.2017 has declared the result of 67 candidates for the post of *Post Graduate Teacher* (Hindi) (Male) in Directorate of Education under **Post code 136/12.**

One post in UR category was earlier kept withheld in view of pending court case in the matter of Hari Dutt vs GNCTD in OA No 2213/15, since the marks of the applicant (Hari Dutt) are less than the marks of last candidate in consideration zone in UR category, as such the vacancy withheld is hereby released. However the marks of the applicant is kept in sealed cover in compliance of the Ld CAT order.
- **3.** On the basis of the merit list of Tier- II examination, additional documents furnished by the candidates whose candidatures were pending and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Hindi) Male **Post code 136/2012**:



- 10. The selection of the above 09 Candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 11. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever

applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

- 12. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 13. Further, the above selection is subject to outcome of cases titled Anil Kumar Vs GNCTD in OA No 4114/17 and Dinesh Kumar Vs GNCTD in OA No 186/18.
- 14. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
