## REJECTION NOTICE NO. 1002 GRADE IV (DASS) IN SERVICES DEPARTMENT UNDER POST CODE 61/2015

- 1. The DSSSB vide its advertisement no. 01/2015 with closing date 26/11/2015 had advertised 1025 vacancies (UR-504, OBC-117, SC-162, ST-242 including PH-26 (OH-10, HH-08, VH-08), EXSM-81, SP-40) for the Post of Grade IV (DASS) in the Services Department under Post code 61/2015. The vacancies for the post code 61/15 has been further revised to 1269 (UR-650, OBC-188, SC-200, ST-231 including PH-63 (OH-10, HH-32, VH-21), EXSM-173, SP-79) vide addendum dated 07.06.2018. The Board had conducted Tier-I written examination on 17/09/2017.
- 2. On the basis of the One Tier written examination, who were shortlisted to appear for typewriting skill test vide notice number 561 dated 18.10.2017, the skill test was conducted by the Board wef from 03/01/2018 to 14.01.2018 and 08.04.2018 for VH category candidates. The result of skill test was declared vide notice number 655 dated 24/05/2018.
- 3. In the result notice no. 740 dated 16/11/2018, candidature of candidate having roll number 15430666 which was earlier rejected in EXSM category was kept as pending for seeking clarification from the Services Department regarding admissibility of OBC Category+EXSM category age relaxation.
- 4. The Services Department had referred the matter to DoPT, GOI and DoPT vide letter dated 03/01/2020 has given clarification in the matter. On scrutiny of the clarifications, it's found that no age relaxation for the OBC Candidate is admissible who is also in EXSM category except the relaxation of age mentioned at point no. 8 and 11 of the OM NO. 15012/2/2010-Estt.(D) dated 27.03.2012 issued by DoPT.

In the light of the clarification of DoPT, GOI and in terms of the advertisement no. 01/2015 and Recruitment Rules for the post of Grade IV (DASS) under Post code 61/15 in Services Department, GNCTD, the candidature of the candidate Kashmir Singh having Roll no. 15430666 under post code 61/15, i.e. Grade-IV (DASS) is found 'Not Eligible' and therefore, his candidature is hereby rejected in the said post code as the candidate was overage even after considering the age relaxation of 16 year and 05 months and three additional year, as admissible to EXSM candidates,
