REJECTION NOTICE NO. 1331
Labour Welfare Officer (Post Code 218/14)
In Delhi Transport Corporation (DTC)

1. The DSSSB vide its Advertisement No. 02/2014 with closing date 25/01/2015 had advertised 02 vacancies (UR-02) for the post of Labour Welfare Officer in DTC under Post Code 218/14.
2. Board Conducted Tier-I written examination for recruitment in respect of this post on 01/09/2019 and 09 candidates were shortlisted for appearing in Tier-II Examination for the said post vide Notice No. 839 dated 13/11/2019.
3. Board has conducted Tier-II written examination (offline mode) of shortlisted candidates on 23/02/2020. Board had declared marks of Tier II written examination of the Candidates of the Post of Labour Welfare Officer under Post Code 218/14 vide notice number 1051 dated 11/09/2020 and e-dossiers were called between 17.09.2020 to 01.10.2020.
4. DSSSB vide Result Notice No. 1059 dated 06/10/2020 has provisionally selected total 02 candidates (UR-02) for the post of Labour Welfare Officer (Post Code 218/14) in Delhi Transport Corporation (DTC).
5. The User Department i.e. Delhi Transport Corporation (DTC) vide letter no. PLD-I/DSSSB/LWO/2021/891 dated 21/09/2021 has returned 01 dossier (UR-01) on the ground that selected candidates do not have requisite educational qualification i.e. bachelor Degree or diploma in social work from University/institution recognized by the Government for the post of LWO in DTC as per RRs for the appointment to the post of Labour Welfare Officer. The validity of the waitlist panel for the post code 218/14 was upto 05/10/2021 and the returned dossier was received prior to expire of waitlist panel, hence, candidate from waitlist panel has been considered for selection against the vacant post created due to returned dossier.
6. On the basis of marks secured in written Examination Tier-II (T) held on 23/02/2020 and after preliminary scrutiny, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions as stipulated in, the candidature of candidates for the Post of Labour Welfare Officer under post code 218/14 in DTC in respect of the following candidates are rejected as per the reasons mentioned against their Roll No. as follows:
