IN SERVICES DEPARTMENT

1. The DSSSB vide its advertisement number 03/13 with closing date 18/10/2013, had advertised 313 vacancies (UR-185, OBC-59, SC-50, ST-19 including EXSM-31, SP-16, OH-04, HH-04 & VH-06) for the Post of Grade II (DASS) in Services Department under Post Code 40/13. Board Conducted Tier I Written Examination on 25.06.2017 and Tier II Examination for the shortlisted candidates was held on 25.11.2018.
2. DSSSB vide Result Notice Nos. 772 dated 19.03.2019 and 776 dated 11.04.2019 have provisionally selected 267 candidates for the post of Grade II (DASS) in Services Department under post code 40/13.
3. User Department, i.e., Services Department, Govt. of NCT of Delhi has returned 18 dossiers (UR-11, OBC-03, SC-02, ST-01, PH(OH)-1) on the grounds that candidates have not responded/join/not found suitable to the post of Grade-II (DASS). Further, 05 candidates (UR-02, SC-02 & ST-01) had also resigned from the post of Grade-II (DASS). The dossiers/resignation cases have been returned before the expiry of waitlist panel. Hence, the Board is declaring the Result of Panel/waitlisted candidates as per their merit.
4. After preliminary scrutiny of the Candidature of the candidates on the basis of documents uploaded/provided by them in their e-dossier as per the provisions of the statutory requirements rule for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of Grade II (DASS) in Services Department under post code 40/13.

- The Candidates having roll nos. 2830001613 and 2830002713 who were earlier selected in OBC Category in this post code have now been shifted in UR Category as per their merit.
- The candidature of 01 candidate is still pending on account of court case i.e. O.A.No. 2333/2017 in the matter of Vishvender & Ors. Vs. DSSSB.
- The selection of the above 23 candidates (UR-11, OBC-05, SC-04, ST-02, PH(OH)-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- The Selection of the above 23 candidates (UR-11, OBC-05, SC-04, ST-02, PH(OH)-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

9. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
 10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
 11. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
 12. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
 13. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
 14. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
 15. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
