- 2. The candidate mentioned at SI. No. 5 under UR category, SI. No. 2, 6 & 8 under SC category, SI. No. 3 & 13 under OBC category are having MCA degree. These candidates are provisionally nominated in the light of the directions contained in the Hon'ble High Court judgment dated 07.08.2013 in the matter of Directorate of Education Vs. Neelam Rana in W.P (C) No.575/ 2013. However, the user Department should thoroughly examine the eligibility of these candidate before issuing formal appointment order.
- 3. The candidate mentioned at SI. No. 1 in SC category above is provisionally nominated under SC category, the user department, is however, requested to verify the caste certificate from the issuing authority before issuing any formal appointment order.
- **4.** While getting the Caste Certificates verified from the issuing authority, special attention should be given to the OBC (D) status of the candidate whose roll no. is mentioned at **SI. No. 22** in OBC category above before issuing any formal appointment letter as the OBC (D) status of this candidate prima facie appears to be incoherent with the Govt. guidelines in view of the documents now uploaded by him in his e-dossier.
- 5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the

candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Physically Handicapped and other essential Certificates.

- 6. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
- 7. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any.
- 8. This issues with the prior approval of the Competent Authority, DSSSB.
