In continuation of this Board's earlier Result Notice No. 49 dated 27/07/2016, Result Notice No. 73 dated 09/09/2016, Result Notice No. 126 dated 10/03/2017 & Result Notice No. 134 dated 03/05/2017, the candidate having **Roll No. 55001006** is provisionally nominated under OBC category on the basis of documents submitted in support of educational qualification, age, etc. in accordance with advertisement no. 01/2013 and RRs for the post of TGT (Social Science) Female (Post Code-13/13) in Directorate of Education. The candidature of this candidate was kept pending for verification of OBC (Delhi) status from the Revenue Department. The Executive Magistrate/Tehsildar (Patel Nagar), Revenue Department has now clarified vide letter No. SDM (PN)/2017-18/OBC/4823-24 dated 25/09/2017 that OBC certificate bearing No. OBC/03/32/5061/7/9/2007/77472 dated 16/10/2007 issued to the candidate is in order.

The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of her identity with reference to her photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after satisfying himself of her eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other Certificates, if any, seeking any relaxation in the eligibility standards. While getting the Caste Certificates verified from the issuing authority, it should be invariably ensured that the candidates claiming benefit under OBC category do not fall under creamy layer as per the latest instructions of the Govt. of India in this regard.

Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

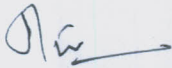
