The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential Certificates.

No. 14 under SC category above have been provisionally nominated on the basis of one year Trade Certificate in Sanitary Inspector obtained from Directorate of TTE, Delhi in the presumption that the said qualification is an equivalent qualification of diploma in Sanitary Inspector as provided in the Recruitment Rules on the analogy that the duration and the nomenclature of the courses are similar.
