- 2. The selection of the above 16 candidates (UR-02, OBC-07, SC-04 and UREXSM-03) is based on submission of photocopy of documents related to age, qualification & caste certificate etc. & original of same have not been seen/verified by DSSSB shall further be subject to fulfilment of all the eligibility conditions as prescribed and the terms and condition of advertisement for the said post. The provisionally selection is also subject to verification of their identity of the candidate their photographs, signatures/handwriting etc.
- 3. The candidature of the candidates are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the eligibility conditions or due to any other genuine reason. Competent Authority of User Department shall issue the appointment letters to the candidates only after satisfying themselves of their eligibility as laid down in the Recruitment verification of the Rules and on correctness of the information/documents/caste certificate/Driving Licence for LMV furnished by the candidates.
- 4. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of written examination have been considered for final appointment in their respective category only.
- 5. The User department shall also check the eligibility of the candidates availing benefit of reservation. Further, wherever applicable, User Department i.e. Transport Department, GNCT of Delhi shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the





information/ documents as furnished in the application forms and documents submitted by the candidate and cross verify the same from the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification regarding successful completion of training for the post before issuing offer of appointment to the candidates.

- 6. Further, the recognition of the Board/Authority/Institution from which the certificates/driving licence to drive Light Vehicles etc. have been issued and submitted by the candidates should also be verified thoroughly by the Transport Department and also verified date of issue & validity of the driving licence as per the RRs.
- 7. Transport Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. Of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993 O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt. (Res) dated 14.08.2008.
- 8. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User Department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respects for appointment to the post.
- 9. Note: OBC (Outsider) candidates have been treated as UR candidates.
- 10. Further, the following 50 Candidates whose documents are not available or are deficient as per RRs. They will be called separately to submit their documents through e-dossier module for the post of Head Constable, (post code 43/13). E-dossier will be active from **06.06.2018 to 20.06.2018:-**
