The selection to the above 02 Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate with reference to his photograph, signature, handwriting and thumb impression etc on the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the DSSSB and the candidate.
