The DSSSB vide its advertisement No 01/2014 with closing date 27.02.2014, had advertised 21 vacancies (UR-10, OBC-05, SC-04, ST-02 including VH-01) for the post of *Post Graduate Teacher (Political Science)* (Female) in Directorate of Education under **Post code 176/2014** in the pay scale of Rs. 9300-34800/- having Grade Pay of 4800/- (Non- Gazetted). No suitable candidate was found in VH category, accordingly the one vacancy in UR category has been kept unfilled as per horizontal reservation norms.

Further, candidatures of candidate having roll number 34002866, 34002027, in UR category; 34004031 in OBC category; 34001933 in SC category and 34002870 in ST Category have been kept pending on account of incomplete document. They are requested to visit the Board along with their complete document on or before 31.03.2017.

Selection to 01 vacancy in OBC category has been kept pending on account of pending candidature of candidate having Roll number 34004257 in post code 150/12 to adjust her in case she is not found eligible in post code 150/12.

Further selection to 03 vacancies in UR and 01 vacancy in ST category have been kept pending in view of related court case pending in Ld CAT/ pending candidatures of candidate in post code 150/2012 to adjust him in case they are not found eligible in postcode 150/2012.

The meritorious candidates who have already been selected for the post of Post Graduate Teacher (Political Science) Female under post code 150/2012, have not been considered for this post, as the DSSSB has conducted the combined examination for the post of 150/2012 and 176/2014.

The selection of the above 12 Candidates shall be further subject to through verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the

original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
