**POST GRADUATE TEACHER (POLITICAL SCIENCE) (FEMALE)
IN DIRECTORATE OF EDUCATION
UNDER POST CODE 150/2012**

The DSSSB vide its result Notices Number 488 dated 17.03.2017 and 494 dated 22.03.2017 had declared the result of 62 candidates for the post of *Post Graduate Teacher (Political Science) (Female)* in Directorate of Education under **Post code 150/2012**.

The candidature of candidate having Roll No 34004257 was kept pending in UR category for want of documents. On receipt of documents it was found that said candidate is not eligible for the post. Accordingly her candidature is hereby rejected. The vacancy thus created is filled by the candidate Ms Raksha Indora (34004525) as per the merit of Tier-II examination. As the candidate Ms Raksha Indora (34004525) had already been selected in SC category vide Result Notice 494 dated 22.03.2017, accordingly her selection is hereby shifted from SC category to UR Category.

Ld CAT vide their order dated 4.7.2017 has disposed off the OA 2232/2015 in the matter of Sharmila & Ors vs GNCTD & Ors. Accordingly, an UR vacancy kept withheld on account of this OA is hereby released. The vacancy thus created is filled by the candidate Ms Arti (34003623) as per the merit of Tier-II examination. As the candidate Ms Arti (34003623) had already been selected in SC category vide Result Notice 494 dated 22.03.2017, accordingly her selection is hereby shifted from SC category to UR Category.

In view of representation of Ms Raj Rani (34002709) who belongs to SC category and having scored 131.75 marks in Tier II examination wherein she had claimed that she was also a candidate for the postcode 150/12. The vacancy created by shifting Ms Arti (34003623) to UR Category shall remain pending till the final decision in the matter of Raj Rani. The candidature of candidate - Ms Indu Bala (34003912) whose selection was kept in abeyance in SC category vide Result Notice No 494, is hereby released against the vacancy created by shifting the candidature of Ms Raksha Indora (34004525) to UR Category. The candidature of candidate Ms Ritesh Anand (34000756) whose selection was kept in abeyance in SC category vide Result Notice No 494 is still in abeyance till finalization of representation of Raj Rani/ the disposal of court case having OA No 2251/2015.

Further, candidatures of the following candidates were kept pending for completion of documents. On receipt of the requisite documents and on the basis of the merit list of Tier- II examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Political Science) Female **Post code 150/2012:**

Further, candidature of candidate having roll number 34004562 in UR category is still pending on account of incomplete documents.

Further, 03 vacancies in UR category, 01 vacancy in OBC category and 01 vacancy in SC category are still pending in view of related court cases in Ld CAT.

The candidature of Ms Nisha Mahavara (34004494) whose selection was kept in abeyance in OBC category vide Result Notice No 494 is still in abeyance till the disposal of court case in Ld CAT having OA No 2242/15.

Further, candidature of candidate having roll number 34000904 is cancelled as the candidate neither possess the BEd qualification nor is first divisioner in 12th class to seek the admissibility of BEd relaxation as per the RRs.

The selection of the above 05 Candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.


The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

Further, the above selection is further subject to outcome of cases titled Priyanka Vs GNCTD in OA No 1157/16, MA 2722/16; Dilshad & Ors Vs DSSSB in OA No 966/17; Manish Sejwal vs DSSSB in OA No 1945/2017 and Mukesh Kumar Vs GNCTD & Ors in OA No 1463/2017.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
