POST GRADUATE TEACHER (POLITICAL SCIENCE) (FEMALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 176/2014

The DSSSB vide its Result Notice No 496 dated 22.03.2017 had declared the result of 12 candidates for the post of *Post Graduate Teacher* (*Political Science*) (*Female*) in Directorate of Education under **Post code 176/2014.**

The candidature of candidate having Roll No 34004257 was kept pending in UR category for want of documents in postcode 150/2012. On receipt of documents it was found that said candidate is not eligible for the post in postcode 150/2012 however her candidature is being considered in postcode 176/2014 in OBC Category, as she was shortlisted in postcode 176/2014 in OBC category on the basis of her score in Tier-I examination.

In view of judgment dated 24.02.2016 in Civil Appeal No 1691 of 2016 arising out of SLP No 27550 of 2012 in the matter of Ram Kumar Girjoya, candidature of Roll number 34004280 (Punam Devi) is being considered in postcode 150/2012, accordingly her selection in postcode 176/2014 is hereby cancelled.

In view of representation of Ms Ritu Mogha (34004005) who claimed to belong to OBC category and having scored 137.5 marks in Tier II examination, her candidature was examined and ascertained that she had applied under OBC category in her online application. The vacancy created by cancelling the candidature of Ms Punam Devi in OBC Category shall be considered at the time of scrutinizing the candidature of Ritu Mogha.

Ld CAT vide their order dated 4.7.2017 has disposed off the OA 2232/2015 in the matter of Sharmila & Ors vs GNCTD & Ors. Accordingly, an UR vacancy kept withheld on account of this OA is hereby released.

In view of above and on receipt of the requisite documents from the candidates whose candidatures were pending and on the basis the merit list of Tier- II examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions

Candidature of candidate having roll number 34001933 is still pending in SC category on account of incomplete document. Further, 01 vacancy in UR category and 01 vacancy in ST category are still pending in view of related court cases in Ld CAT.

Further the Candidature of the candidate having Roll number -34003456 in UR Category remains pending on account of pending candidature of candidate having Roll Number 34004562 in postcode 150/12, to adjust her candidature in postcode 176/14 in case she is not eligible in postcode 150/12.

The selection of the above 04 Candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing

authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

Further, the above selection is further subject to outcome of cases titled Priyanka Vs GNCTD in OA No 1157/16, MA 2722/16; Dilshad & Ors Vs DSSSB in OA No 966/17; Manish Sejwal vs DSSSB in OA No 1945/2017 and Mukesh Kumar Vs GNCTD & Ors in OA No 1463/2017.
