Stenographer Grade III in Services Department under Postcode 211/2014

Board had declared marks of Tier-I written examination of the candidates of the post of Stenographer Grade III in Services Department under Post code 211/2014 vide notice number 550 dated 06.10.2017.

Based on the performance in Tier-I written examination, 489 (four hundred eighty nine) candidates who have obtained marks above the cutoff marks, based in the ratio of 1: 10 ratio subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms, have been shortlisted for appearing in Shorthand and Typewriting (English) Skill Test. **The short listed candidates shall be called for Skill Test separately.** The category wise cut off marks are as under:

The shortlisting of the candidates for appearing in Skill Test is purely provisional, subject to verification of credentials & documents for determination of eligibility for the post to be carried out by the Board after skill test.

The OMR sheets of 43 candidates, who appeared in the combined examination for the post of Junior Stenographer (English) in NDMC under Postcode 47/2012; Stenographer, Grade III In MAIDS under Postcode 152/2014 & Stenographer, Grade III In Services Department under Postcode 211/2014 Postcode have not been evaluated due to various reasons such as writing of roll number of absent candidates, due to wrong bubbling of roll number/question booklet series, duplicate roll numbers etc..

The OBC candidates have been shortlisted for appearing in Skill Test in OBC Category, on the basis of details provided by them in their online application forms.

Aforesaid reserved category candidates who had obtained marks above or equal to the last qualified UR candidates have been declared qualified for appearing in Skill Test against UR vacancies.

As per the Board notice dated 26.04.2013, the minimum qualifying marks in two tier written examinations for General candidate is 40%; for OBC candidate is 35%, for SC/ST/PH candidate is 30% and for ExSM candidate is 5% relaxation in their respective categories subject to a minimum of 30%.

While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
