**POST GRADUATE TEACHER (PHYSICAL EDUCATION) (MALE)
IN DIRECTORATE OF EDUCATION
UNDER POST CODE 173/2014**

The DSSSB vide its advertisement No 01/2014 with closing date 27.02.2014, had advertised 01 vacancy (UR-01) for the post of *Post Graduate Teacher (Physical Education) (Male)* in Directorate of Education under **Post code 173/14** in the pay scale of Rs. 9300-34800/- having Grade Pay of 4800/- (Pre- revised) (Non- Gazetted). The Board had conducted Tier I examination on 30.11.2014. The Tier II examination held on 28.06.2015 was cancelled vide Notice dated 03.11.2015 and was again conducted on 26.06.2016.

The marks of Tier-II examination was declared vide Notice No. 569 dated 08.11.2017 and e-dossiers from the shortlisted candidates have been obtained. On the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (*Physical Education*) (*Male*).

**in respect of candidate having Roll No.30000476 his father's name is mentioned as 'Kishan Rathⁱ' in his educational documents certificates however mentioned as 'Kishan Kumar Rathⁱ' in his online application form and OBC certificate.*

The selection of candidates having Roll No. 30000476 is purely provisional subject to satisfaction of the user department in regard to the remarks mentioned against each.

The meritorious candidates who have already been selected for the post of Post Graduate Teacher (Physical Education) Male under post code 145/2012, have not been considered for this post, as the DSSSB has conducted the combined examination for the post of 145/2012 and 173/2014.


The selection of the above 01 Candidate shall be further subject to thorough verification of the candidature of the candidate by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
