POST GRADUATE TEACHER (HINDI) (MALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 169/2014

- 1. The DSSSB vide its advertisement No 01/2014 with closing date 27.02.2014 had advertised 12 vacancies (UR-06, OBC-03, SC-02, ST-01 including VH-01) for the post of *Post Graduate Teacher (Hindi) (Male)* in Directorate of Education under **Post code 169/14** in the pay scale of Rs. 9300-34800/- having Grade Pay of 4800/- (Pre- revised) (Non- Gazetted). The Board had conducted Tier I examination on 30.11.2014. The Tier II examination held on 28.06.2015 was cancelled vide Notice dated 30.07.2015 and was again conducted on 26.06.2016.
- 2. The marks of Tier-II examination was declared vide Notice No. 546 dated 06.10.2017 and dossiers from the shortlisted candidates have been obtained. On the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Hindi) Male **Post code 169/2014**:

- 10. The candidates who have already been selected for the post of Post Graduate Teacher (Hindi) under post code 136/2012 as per their merit, have not been considered again for selection in postcode 169/2014, as the DSSSB has conducted the combined examination for the post of 136/2012 and 169/2014.
- 11. The candidate Pradeep Kumar (22001866) has been working in Navodaya Vidyalaya, which is an autonomous central Government body. As per the DOPT OM No 15012/2/2010-Estt (D) dated 27.02.2012, the age relaxation as admissible to Government Servants is not granted to employees of autonomous organization. Therefore the same is not admissible to him and his candidature is rejected.
- 12. The candidature of the candidate having Roll Number 22002842 has been cancelled as the candidate concerned has not uploaded his documents in e-dossier module in compliance with Notice No 546 dated 06.10.2017.
- 13. The candidate having Roll Number 22002717 was not called earlier for uploading of e-dossier vide notice dated 06.10.2017, he is hereby called for uploading of e-dossier in ST category for considering her candidature in Wait/Panel List.
- 14. The candidature of the candidate having Roll Number 22002484 is kept pending in OBC category for want of OBC Delhi certificate as the candidate has furnished OBC (Govt. of India) Certificate. Further the candidature of the candidate having Roll Number 22002705 is kept pending in OBC category as the candidate has furnished the OBC certificate after cut-off date for seeking clarification of admissibility of such certificate.
- 15. The candidature of candidate having Roll Number 22002773 is pending in SC category till the finalization of candidature of candidate having Roll Number 22007575 in postcode 136/12 to consider his candidature in postcode 169/14 in case he is not selected therein.

- 16. The selection of the above 09 Candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 17. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 18. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 19. Further, the above selection is subject to outcome of cases titled Anil Kumar Vs GNCTD in OA No 4114/17 and Dinesh Kumar Vs GNCTD in OA No 186/18.
- 20. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 21. This issues with the prior approval of the Competent Authority.
