POST GRADUATE TEACHER (HINDI) (FEMALE) IN DIRECTORATE OF EDUCATION **UNDER POST CODE 170/2014**

- The DSSSB vide its advertisement No 01/2014 with closing date 27.02.2014 had advertised 21 vacancies (UR-10, OBC-06, SC-03, ST-02 including OH-01) for the post of Post Graduate Teacher (Hindi) (female) in Directorate of Education under Post code 170/14 in the pay scale of Rs. 9300-34800/- having Grade Pay of 4800/- (Pre-revised) (Non-Gazetted). The Board had conducted Tier I examination on 30.11.2014. The Tier II examination held on 28.06.2015 was cancelled vide Notice dated 30.07.2015 and was again conducted on 26.06.2016.
- The marks of Tier-II examination was declared vide Notice No. 547 dated 06.10.2017 and dossiers from the shortlisted candidates have been obtained. On the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (Hindi) Female **Post code 170/2014**:

- 8. The candidates who have already been selected for the post of Post Graduate Teacher (Hindi) under post code 137/2012 as per their merit, have not been considered again for selection in postcode 170/2014, as the DSSSB has conducted the combined examination for the post of 137/2012 and 170/2014.
- 9. The candidature of the candidates having Roll Number 22007767, 22006631 have been cancelled as the candidate concerned have not uploaded their documents in e-dossier module in compliance with Notice No 547 dated 06.10.2017.
- 10. The candidature of the candidate having Roll Number 22005106 is kept pending in UR category for furnishing of her 10th Certificate. Further the candidature of candidate having Roll Number 22006920 is kept pending in UR category for furnishing of the documents regarding claiming age relaxation.
- 11. The candidature of the candidate having Roll Number 22000161 is kept pending in OH category for furnishing of her disability Certificate.



- 12. The selection of the above 18 Candidates shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 13. The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates for appearing in Tier-II examination on the basis of their Tier-I examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 14. Mere inclusion of the name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 15. Further, the above selection is subject to outcome of cases titled Anil Kumar Vs GNCTD in OA No 4114/17 and Dinesh Kumar Vs GNCTD in OA No 186/18.
- 16. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
