1. The DSSSB vide its advertisement number 01/2015 with closing date 26.11.2015 had advertised 06 vacancies (UR-02, OBC-02, SC-1 & ST-1) for the post of Welfare Officer in Social Welfare Department under Post code 55/2015 in the pay scale of Rs. 9300-34800/- having Grade Pay of 4200/- (Pre-revised). Board has conducted One Tier Examination (G) for recruitment to this post on 27.08.2017. Marks of 185 candidates who appeared in the examination and whose OMR sheets have been evaluated have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on [www.dsssonline.nic.in](http://www.dsssonline.nic.in).

2. Based on the performance in the examination, 17 candidates, as detailed below, have been provisionally allowed to upload e-dossiers in the ratio of 1:3 of the advertised vacancies, taking all candidates who have scored marks equal to the cut off subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

3. The OMR sheet of 04 candidates having serial number 201891, 201952, 201997 and 202059 have not been evaluated due to wrong bubbling of roll number.

4. Kindly note that the e-dossier link will be activated for only those candidates who are in the consideration zone of selection. SMS to these candidates are also being sent on their registered mobile numbers in OARS. Separate e-mail on their registered e-mail id is also being sent.

5. All the candidates who have been shortlisted for uploading their e-dossier MUST upload their all requisite/applicable documents in the said link including applicable Post Graduation Degree, Mark Sheets of all years/semesters of Post Graduation Degree, 10<sup>th</sup> Certificate, Caste Certificate (if applicable).

6. The e-dossier link shall be active from 14.02.2018 to 28.02.2018.

7. While every care has been taken in preparing the list of candidates for uploading the e-dossier, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

8. Mere asking the candidates for uploading documents in the e-dossier module does not confer them any right to selection to the applied post. Final Selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfils all the required eligibility conditions.

9. It is also clarified that candidate who fails to upload their documents on or before the date as mentioned above will not be given any further opportunity and their candidature will be treated as cancelled/ rejected.


