**TGT (URDU) (FEMALE) IN DIRECTORATE OF EDUCATION  
UNDER POST CODE 16/2010**

1. The DSSSB vide its result notices number 244 dated 05.03.2014, 259 dated 14.07.2014 and 272 dated 18.09.2014 has declared result of 06 candidates (05 UR, 01 OBC) for the post of TGT (Urdu) (Female) in Directorate of Education under Post code 16/2010 in the pay scale of Rs. 5500-9000 (pre-revised).

2. At the time of declaration of result of the candidature of candidate having roll number 01610016, was kept pending for seeking clarification from user department regarding admissibility of her 'Adeeb-e-Kamil' qualification for the post. The Directorate of Education vide their letter number DE.3(54)/E-III/DR/pf(3)/TGT(MIL)/2016/2290 dated 08.02.2018 has informed that the candidates having 'Adeeb-e-Kamil' from Jamia Urdu, Aligarh Muslim University may be considered for the post of TGT(Urdu) in the Directorate of Education, GNCT of Delhi.

In view of the above mentioned clarification dated 08.02.2018 of Directorate of Education and on the basis of the merit list of part-II examination of the post held on 12.05.2012 and after preliminary scrutinizing eligibility for the post as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of TGT (Urdu) (Female) in Directorate of Education under **Post code 16/2010**

The selection of the above Candidate shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate with reference to her photograph, signatures, handwriting and thumb impression etc on the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the

Recruitment Rules of the posts or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.

6. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ document as furnished in the application form vis-à-vis from the original documents as well as authenticity of document/certificates before finally appointing the candidate.

7. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
